# Keeping Your Tribe Safe:

### What is a Cyber threat PoP-SLAM and what value does it provide to my Tribal organization?

As the tools and techniques employed in modern credential theft attacks evolve, attackers are finding it easier to achieve their goals through widely known and commonly used attack vectors. Credential theft and reuse as a means for lateral movement between systems is arguably the most commonly used vector in most organizational compromises. Proactive Operations Program - Securing Lateral Account Movement (POP-SLAM) is a three-day engagement with a Microsoft Premier Field Engineer working alongside the customer's security and Active Directory staff. The deliverables will consist of training, knowledge transfer and implementation of the recommended mitigations in a customer provided lab. Optionally, a customer may choose to perform a basic implementation in their production environment after testing in a lab environment.

Credit card breaches, phishing attacks, virus attacks and ransomware breaches all increased in 2019. Make 2020 the year you engage your organization in connecting to available security resources and joining in the security information sharing conversation. TribalHub and our industry partners are working to support all tribes in their efforts to secure and protect their organization and information. Here are three simple things you can do to boost your security resources and capabilities in 2020:

1. Join the Multi-State Information Sharing and Analysis Organization (MS-ISAC). This is a FREE resource available to every tribe. You can join online at https://www.cisecurity.org/ms-isac/ms-isac-members/

2. Join the TribalHub/TribalNet discussion on forming a Native American security information sharing network. This group of technology leaders from tribes across the United States is currently meeting via conference calls to discuss the formation of a security group representing all tribes. The group is all about tribes working together to protect tribes and all of our similar interests and systems. 3. Ask for assistance from resources that understand tribes and tribal enterprises. # What else is happening across the industry in 2020?

### COULD YOUR TRIBE BENEFIT FROM THE RURAL TRIBAL PRIORITY WINDOW LICENSE?

The FCC is giving tribes a priority window period to acquire spectrum licenses in the 2.5 GHz band, before they are offered to the general public. The window will open on February 3, 2020, and close on August 3, 2020.

Any federally recognized Tribe or Alaska Native Village may apply for spectrum in the Rural Tribal Window. Consortia of federally recognized Tribes and/or Native Villages, or other entities controlled and majority-owned by such Tribes or consortiums, are also eligible to apply.

The FCC website at **www.fcc.gov/RuralTribalWindow** provides information regarding the type of licensing available in rural tribal lands. Licenses come with certain conditions and requirements. There is also a **mapping tool** to assist tribes in assessing their eligibility and the amount of unassigned 2.5 GHz spectrum over their Rural Tribal Lands.

### START PREPARING NOW FOR THIS OPPORTUNITY

Tribes should begin preparing now to acquire licenses and should take into consideration time allotted for application processes, technical requirements, and any tribal council actions and timeframes that may impact decision-making. The next opportunity to learn about the process in greater detail and participate in a workshop to learn how to apply for licenses is January 14, 2020 during the FCC Rural Tribal Priority Window Workshop.
